### 4 Coutts ebook acquisition (University of Birmingham)

- All have been raised with Coutts previously:
  - 1) The process seems to have changed whereby we are now receiving individual activation spreadsheets per ebook ordered via Coutts one by one. We used to get a spreadsheet which bulked these together which enabled us to efficiently get the docIDs needed together, rather than 20 individual spreadsheets.

**Response ProQuest:** This issue has now been resolved.

- 2) Would it be possible to receive a scheduled daily summary document each day listing which ebook titles have got turnaways and how many? We do get individual title turnaway emails as they happen from PQ/EBC, but you can't run a live report on turnaways, it doesn't update for a day or two. We have to sift through hundreds of individual emails to be responsive to turnaways.

**Response ProQuest:** Rebecca Ursell pointed to two open enhancement requests on the Idea Exchange which can be voted for.

- 3) Automatic upgrades in response to ebook turnaways. You can currently set it to trigger an auto-upgrade or additional licence purchase after 1 turnaway. Please could we request if there could be an option to customise this, for example trigger a purchase after 5 turnaways in 24 hours?

## 5 Any other user issues

### Performance of Ulrichsweb (Open University)

Wendy Mears reported experiencing performance issues since Ulrichsweb moved to the ProQuest platform.

**Response ProQuest:** Not aware of any performance issues, advise opening a ticket to investigate further.

### Duplication of content in Open Access collections in the community zone / Open Access Complete Collection (University of Nottingham)

Sarah Davies reported that some Open Access collections in the community zone were not up to date including the Directory of Open Access Books (DOAB) collection. With the introduction of the Open Access Complete Collection on Ebook Central questions were raised about the level of duplication across other collections and how best to make Open Access content available across ProQuest products to ensure currency and avoid administrative burden.

Alexandra Follett followed up that records are merged in the Central Discovery Index (CDI) so that duplicate records are de-duplicated.

- 6.2 Elsevier / Academic Press withdrawals from the Proquest Academic Complete ebook subscription (Open University)** - Action Rebecca Ursell: Investigate the Taylor & Francis instance and revisit the June date for removals. August proposed instead of June.

**Update Rebecca Ursell:** There does not appear to be a pattern of Taylor & Francis removing large numbers of titles from Academic Complete. Many more titles have been added than removed in the last few years. The date for removals from Academic Complete remains under review but is unlikely to change in the near future as it's a very complex issue.

- 6.3 Requesting official contract for a new resource, particularly multi-year agreements (University of Birmingham)**
