Minutes of the last ordinary meeting (August 2014):

Follow-up actions from the last meeting:

- MIMAS update (JH) MIMAS has been absorbed by JISC as of August 1st with the last board meeting held in 2013. Keith Cole(director of MIMAS) now working at JISC Action FB to contact Keith Cole to see where and how JIBS may be involved.
- Archiving YC reported everything is up to date on the server.
- JIBS Prize 3 entries from UCL, Aberystwyth and Sheffield. 2 have been circulated to JIBS panel of judges but remaining entry file is too large so it will be put on Google docs. *Action for JH, EMcH, EM and NT to decide on winning entry by end December.*
- Scopus rep Action FB to contact Carol Rhodes regarding Klara joining Scopus panel.

JISC liaison

EIRWG – EMcH attended the September meeting and gave update on BSOL, Wiley and T&F deals. JISC banding is to be normalised; there will be a pilot for NHS and JUSP was discussed.

Reports on liaison activity

Edina (EM) – still awaiting minutes of July meeting. Next meeting arranged for end November. **Eduserv** - Jenny Carroll attending this meeting at lunchtime but the committee discussed access to resources for FE franchises. It was reported that Springer access to older content had disappeared. New deal for Euromonitor coming out in 2015.

FE – JW chair of the FE Colleges committee. Meeting to be held later in November. **Research Councils** – MJ reported that at the last meeting the main point of discussion was SWETS.

Reports on enhancement groups

BSOL – Liam Earneys update here****

IHS – Action FB to contact Frances Hyde as no recent updates received.

EBSCO – Discussion around Ebsco's poor indexing problems with Summon and new content not linking/searchable. *Action for NT, FB and AE to forward specific issues that they have encountered at their institutions to Sara Thompson in order to disseminate to enhancement group.*

OVID – (Mark Clowes) Nothing to report other than meetings are now held once a year only.

Proquest - (Catherine Robertson) reported that:

- Refworks Flow Proquest to check copyright and legal implications of sharing academic material between users from other institutions.
- OU has done some accessibility checking on the PQ platform, and found only minor issues which were fed back to PQ.
- PQ asked if people interested in altmetrics- the answer was yes as long as the data was clear, as no-one has the time to analyse lots of raw data.
- Getting PQ content in Primo Central- some content exchange has been agreed by the two
 companies and are being tested at selected sites.
- CSA databases-all customers should have been contacted about their access so individuals to contact PQ directly with queries.
- Dissertations and Theses old platform is still visible as some links have yet to be moved, but this is being worked on.
- Eventually all PQ products should be on the main PQ platform and work is ongoing behind the scenes to facilitate this but it is a big task.
- Ebooks-a new version of the Ebrary reader has been released and new customers are being added to it gradually. There will also be a combined platform which contains both Ebrary and EBL.

IGI Global - information technology management, education and science journals and eBooks

A well-known reference eBook publisher...shhh! **Lynda.com** – online tutorials and training videos for software, creative, and business skills. We've started discussions with this provider and we're going to need a great deal of support from the community providing feedback. One of the biggest issues will be for us to find a way for institutions to consolidate purchases from

departments/faculties/schools or even individuals. FT.com and The Economist have both withdrawn content from third party resources or content is embargoed. This is causing headaches and the price models are unsatisfactory/unaffordable. Publishers have been resilient to approaches from all third parties. We continue to collaborate with the BLA and apply pressure at every opportunity them to find a satisfactory pricing model. We need the community to hold back from subscribing and encourage the publishers to negotiate a creditable agreement.

Business and Management Resources - following a recent meeting of the Eduserv Focus Group we now have a raft of resources to investigate or re-investigate; Bloomberg, EIKON, Brad Insight, ECCH, Henry Stewart, Sage, RSC, XpertHR and WARC...watch this space. As ever we will be seeking information on your current subscriptions and feedback on any proposals.

In 2013/14 Chest Agreements saved the collective academic community over £46 million on software and online resources licences.

Open Access

Last year we successfully negotiated a 25% discount on prepayment of IEEE APCs. Our recent survey has revealed that there are at least 15 other publishers that we can approach to get you better value for money. Institutions do have reservations around prepayments and double dipping. We have invited a group of people to take part in a workshop to help us to work out what we should negotiate for.
